Those are program dollars, and will support our CDA class and graduation, and emergency supplies for families that come here, like formula etc.		
	Beverly Batson, our former Board Member, donated \$2k in unrestricted funds. She has applied to be an Honorary Board member and connections within Broward, she provided connections with Oakland Park who donated SR match dollars.		
	Broward county has something called socially good, and we are looking to connect with them. They help coordinate fundraisers for non-profits.		
	We also had another application from someone Richard Campillo recommended. We want them to attend the next Nomination meeting.		
	We would love to have something small in the future, but it takes a lot of staff time and resources to have one and not a lot is coming in from that.		
	Acting Chair Kirk Englehardt, suggested that as we get donors/donations we should think of ways to recognize them. Like the Kiwanis, once we established what we are doing with the money, we should post pictures and tag them so they can see what was done with their donations and then they can even share with other people.

Background

In FY22/23, the ELC Broward launched the Ad Hoc Fundraising committee and developed the role of the committee/committee members, fundraising parameters and goals.

In FY23/24, the Ad-Hoc Fundraising committee provided feedback and guidance for year 1 of the Coalition's plan to fundraise and friend raise. Committee members committed to assist with recruiting Honorary Board members and connect the organization to potential "friends" and/or donors. ELC staff hosted their first-ever (and successful) fundraising event and developed strategies to generate more unrestricted and program income. As you can see in the below charts, the ELC secured an approximate total of \$30,000.

Program Income and Unrestricted Funds Raised Through Fundraising

Staff raised nearly \$27,000 in Program Income in FY 2024. Approximately \$17,000 was used to serve food to educators during onsite training sessions, \$3,270 in CPR fees paid for CPR certificate issuance and the remaining balance was used for CDA graduation events, A Day in K at the Museum of Discovery & Science, and a Volunteer Harvest food packing event at the ELC.
