Regular Committee

 FUND241RB1- Fundraising Strategies Renee shared that we've been busy planning our first ever fundraising event at the Small Wine Shop in Ft. Lauderdale. The cost is about \$1700 dollars. We were able to get two sponsors for the event. Our legal counsel Goren, Cherrof, Ezrol, & Doody donated \$1,000, and we collected the remaining \$750 from State Farm. This is meant to be a small-scale event for potential new donors, sponsors, and "friends" of the ELC with the hope of planning a larger fundraising event down the road.

Renee shared that we are currently developing a new Donations landing page on our website. Some minor changes were already made but it is still not the final product. We had a minor setback because the company that was going to design our landing page wanted to charge us a merchant fee but since we have an existing merchant relationship, we decided to go another route and re-design the original page.

Renee requested the committee spread the word about the fundraiser on September 11th, 2023 at our next board meeting, when the co-chairs report out to garner support for this event. We ask that the Co-Chair encourage every board member to bring two people to the event.

Door Prize Discussion

Renee shared that Kristina West at PNC donated a door prize of a lounge box at a Miami Heat game, which includes six tickets. After much discussion, the committee agreed we should not sue this valuable gift at the small upcoming event. The committee thought giving away a wine basket would make a good door prize while we find a better way to use the lounge box. Kristina shared that if we don't use the lounge box for this event, then her offer was still good for a later date.

CEO Renee Jaffe shared that Fundraising Chair Kristina West is resigning from the Board due to time constraints and her workload at PNC. It was also shared that Kristina is considering applying for an Honorary Board Member.

Event Timeline:

A discussion was had regarding the format and messaging of the event. Renee shared her hopes that this event be more intimate and less formal, and the committee agreed.

Event Invitation:

Renee shared that over this past year, we have had to rely on Board member donations to fund Meet & Greets, Lunch & Learns, and other initiatives, and she shared how appreciative she was for those dollars. While board members can offer to donate funds at any given time, we have created an annual campaign document (given out to board members at the beginning of the fiscal year) for board members to donate to the ELC.

Background

In FY22/23, the ELC Broward launched the ad hoc fundraising committee and met serval times to develop the role of the committee/committee members, develop fundraising parameters and goals, and provide feedback related to plans for the ELC's first-ever fundraising event. The committee and ELC staff developed a development plan for fundraising efforts and provided input throughout the planning process for ELC's fundraising efforts.

Additionally, the committee worked collaboratively with the Nominating and Governance Committees to create a new Honorary Board membership option, approved by the Board at the April 20th meeting with finalized (Honorary Board membership) bylaw language and an application (and nomination process) approved at the June Board meeting.

In March 2023, PNC Bank generously donated \$5,000 in seed money to fund ELC's initial fundraising efforts. Utilizing this seed money, ELC staff began planning for the organization's first "Meet and Greet" fundraising event, which took place on October 5th. The event's goal was to attract new community partners and/or new potential "friends" and/or donors of the ELC. The event, which proved to be successful, was held at a local wine shop in downtown Fort Lauderdale, where attendees sampled wine and cheese and learned more about the ELC and opportunities to get involved.

Current Status
